The Early Child Mental Health Group plans to take the proposal to MO HealthNet. As there is much information in this report, the Board members requested time to discuss it with their respective workgroups/organizations and bring back for the January agenda.	
	Addition to Early Care and Education Workgroup Carol Scott requested Board approval to add Rebecca Curtis of the Francis Institute and Liz Smith from Mid-America Head Start at MARC to the ECE Programs Workgroup. Board approval was given by consensus.	
	Nominating Committee Roseann Bentley, Brenda Shields and Stacey Pries have been requested, and with no objections from the Board, have agreed to serve as the nominating committee. 	S1086 – Child Care and Development Block Grant (CCDBG) Cindy Burks reported on the next step after the approval of the CCDBG. The bill will be voted on by the Senate on November 13, 2014 and seems imminent to pass, and go to the desk of the President. At the point there will be a 6-month countdown with hopes to begin work in May 2015. Having not passed in FY'14 allowed extra time to put in place a well thought out plan	
	Missouri Accreditation Letter As an addendum to the agenda, there was a discussion of a letter from James Watkins, president of MO Accreditation. Erin Brower of Alliance for Childhood Education had stated in "What Changed" that MO is the only state without quality standards. Pam Speer of MO Accreditation said the statement had raised many questions about why accreditation is not considered a set of quality standards. This is not the view of CBEC as CBEC is aware there are many quality accreditation organizations.
