DISCUSSION:

The purpose of this memorandum is to inform staff of a change that has occurred within the Children's Division, Child Care Provider Relations Unit. The Child Care Provider Relations Unit has separated into a Child Care Provider Registration Unit, managed by the Early Childhood Preventative Services Section of the Children's Division (ECPSS) and a Child Care Payment Unit managed by the Division of Finance and Administrative Services (DFAS).

Child Care Provider Registration Unit

The Child Care Provider Registration Unit is located in Jefferson City and is responsible for processing all child care provider registrations and registration renewals, provider contract information, provider address changes, as well as any changes that affect the child care provider's status as a registered or contracted child care provider. If an individual has questions regarding being registered or contracted to provide child care services to subsidy eligible children, they should be directed to the Child Care Provider Registration Unit.

Child Care Payment Units
