DISCUSSION:

The Missouri Employment and Training Program (METP), for Food Stamp participants, is considered a valid need for the Child Care Subsidy program. Verify and document the participants are enrolled in the METP program. To show METP is the need for child care, enter MET on the CCNEED (FMAC) screen in FAMIS.

Authorize the children based on the number of hours the parent(s) is participating. If there are two parents in the household, both parents must have a valid need for care either both participating in the METP or one participating in the METP and the second parent participating in another valid need.
