## **Public Notice Regarding Prospective Professional Dispensing Fee Changes**

January 13, 2021

Pursuant to Sections 1902(a) 13(A) of the Social Security Act, 42 Code of Federal Regulations (CFR) 447.205, which mandate that proposed changes in statewide Medicaid payment methods and standards be published and made available for review and comment, this is to advise that:

1. The Missouri Department of Social Services, MO HealthNet Division provides notice of the following:

To ensure efficiency, economy, quality of care, and access, 13 CSR 70-20.060 Professional Dispensing Fee is amended in conjunction with the State Plan Amendment Attachment 21-0008, effective for dates of service beginning February 1, 2021, the MO HealthNet Division (MHD) will change the professional dispensing fee applied to pharmacy drug claims for prescribed drugs, including specific MO HealthNet covered non-legend drugs and legend drugs that are prescribed by an authorized prescriber. The MHD estimates a total savings of \$50,617,887 annually as a result of this change.

- A. For pharmacy provider claims, a professional dispensing fee will be applied as outlined below.
  - a. Out-of-state pharmacy providers receive a professional dispensing fee of \$8.85.
  - b. In-state pharmacy providers receive a professional dispensing fee of \$12.22, plus an adjustment to account for the costs of the Missouri Pharmacy Reimbursement Allowance attributable to Medicaid-reimbursed prescriptions.
  - c. Long-term care pharmacy providers receive an additional \$0.50 professional dispensing
  - d. A professional dispensing shall be added to maintenance medications no more frequently than once every 25 days.
